Perkins County Sheriff Jim Brueggeman spoke to the Board regarding contracting dispatch services from Keith County for Perkins County. Brueggeman told the Board he was there to basically start the conversation between Keith County and Perkins County. Brueggeman asked the Board if Keith County had the capability to do this, if Keith County would be interested in doing this and a rough estimate of what Keith County would charge for this service. The Board will ask Emergency Management Manager Pete Peterson to help work on this.

County Attorney Randy Fair spoke to the Board on the Sandhills District Health Department's audit. Fair instructed County Clerk Sandra Olson to put the Sandhills District Health Department audit report discussion and an executive session for Sandhills District Health Department audit report on the April 22, 2015 agenda.

Johnson spoke to the Board regarding the health insurance review with the Plan IT. Johnson will speak to Spencer Thomas with Cobecon and have more information for the Board next week.
