City Manager Aaron Smith spoke to the Board about the Interlocal Agreement between the City of Ogallala and Keith County for ambulance services. Armour moved to approve the Interlocal Agreement as drafted, Baltzell seconded the motion. O'Connor, Johnson, Baltzell, Armour and Peters voting aye; none voting nay; motion carried. This interlocal agreement will be filed in the Resolution Book as number 2015-8.

Highway Superintendent Tim Ryan presented the One and Six Year Road Plan. Baltzell moved to adopt the resolution approving the One and Six Year Road Plan, Armour seconded the motion. Johnson, O'Connor, Armour, Baltzell and Peters voting aye; none voting nay; motion carried. This resolution will be filed in the Resolution Book as number 2015-9.

Zoning Administrator Jack Quinlivan presented the Board with a resolution for Change of Zone #15-1 by Ted Lunn to rezone from Residential Rural Two District (RR2) to Residential Medium Density District (RM) property located in Lots 11 & 18, Payne's Subdivision, located in Section 5, Township 14, Range 37. Quinlivan told the Board that the Planning Commission had recommended approval for this change of zone. Armour moved to adopt this resolution, O'Connor seconded the motion. Baltzell, Johnson, O'Connor, Armour and Peters voting aye; none voting nay; motion carried. This resolution will be filed in the Resolution Book as number 2015-10.

O'Connor moved to approve the travel request of Zoning Administrator Jack Quinlivan to attend the Nebraska Planning and Zoning conference, Armour seconded the motion. Baltzell, Johnson, Armour, O'Connor and Peters voting aye; none voting nay; motion carried.
