Vail and Visitors Committee member Deb Schilz spoke to the Board on the unfinished business agenda item of the Oregon Trails Home Builders grant request. Schilz also spoke to the Board regarding possible new guidelines for the Improvement grant applications.

Baltzell moved to approve the Oregon Trails Home Builders grant request in the amount of \$1,000.00, Armour seconded the motion. O'Connor, Johnson, Armour, Baltzell and Peters voting aye; none voting nay; motion carried.

County Attorney Randy Fair entered the meeting at 8:38 a.m.

Clerk of the District Court Tina DeVoe spoke to the Board regarding boxes of records that are currently stored at New Perspectives. DeVoe told the Board that New Perspectives has approximately 39 boxes of District Court records and that New Perspectives had given her an estimate of \$2,437.50 to scan the records and destroy them. DeVoe said the other option was to go there and bring the boxes back. It was noted that there was not enough in DeVoe's budget to have them scanned or retrieved in this budget year. DeVoe will contact New Perspectives and ask them if they would house the records until next budget year and find out what it will cost to have them shipped back.

Armour moved to reappoint Larry Cummings to the Hospital Authority Board, O'Connor seconded the motion. Baltzell, Johnson, O'Connor, Armour and Peters voting aye; none voting nay; motion carried.

Baltzell moved to authorize Chairman Peters signing the amended Interlocal Agreement with the Southwest Public Health Department, O'Connor seconded the motion. Johnson, Armour, O'Connor, Baltzell and Peters voting aye; none voting nay; motion carried. This agreement will be filed in the Resolution Book as number 2015-5.

No action was taken on the agenda item of the Ogallala/Keith County Chamber of Commerce Visitors Committee public records request. This item will remain on the agenda under unfinished business until the Attorney General's opinion is received.

On the Sandhills District Health Department bad debt agenda item Peters reported that the satellite phone that was purchased from the State of Nebraska had been returned to the State of Nebraska. No action was taken. The bad debt for the Sandhills District Health Department will remain on the agenda under unfinished business.

At 9:55 a.m. O'Connor moved to go into executive session to conduct employee evaluations with no decisions to be made, Johnson seconded the motion. Baltzell, Armour, Johnson, O'Connor and Peters voting aye; none voting nay; motion carried. Peters stated they would be going into executive session to conduct employee evaluations with no decisions to be made. At 11:07 a.m. Armour moved to return to open session with no decisions having been made, Baltzell seconded the motion. O'Connor, Johnson, Baltzell, Armour and Peters voting aye; none voting nay; motion carried.
